6) New Business

a. <u>Moffatt & Nichol's Proposed Contract Amendment #50</u>. BBGHAD Engineer seeks supplemental budget for Coastal Frontiers' Spring and Fall 2023 Beach Profile Survey Program and Annual Report in the amount of approximately \$101,820, which includes a \$10,000 allowance for consulting/advice from Russ Boudreau as needed by the BBGHAD. See attached Staff Report (Project Counsel/Project Engineer).

Staff Recommendation: Approve Moffatt & Nichol's proposed budget supplement as the benefits of obtaining additional spring data lie in future pre-and post-Project comparison of beach conditions and bio-resource health. Conducting a 2023 Spring Survey would assist the BBGHAD in understanding the impact and severity of Winter storms, and document below-water deposition in the nearshore bar, especially rocky habitat at Lechuza Point. The SAP prioritizes physical processes, and this work will greatly assist explaining such physical processes.

b. <u>BBGHAD CPI Assessment Increase</u>. As the yearly August deadline approaches for the BBGHAD to submit its assessment roll to LA County, the Board will consider adjusting the levy on the current BBGHAD assessment. The Board will consider adoption of Resolution No. 2023/02, which would add the 2022-23 CPI adjustment (when it is published) to the current assessment such that the Board-approved assessment shall appear as a line item on the property tax bills of all BBGHAD properties (and a separate invoice issued to Malibu West, which, we understand, does not receive a property tax bill) for the upcoming tax year (Project Counsel/Clerk).

Staff Recommendation: Adopt Resolution No. 2023/02, which will set the process for adding a CPI adjustment to the BBGHAD assessment for the upcoming tax year.

c. November 2023 BBGHAD Board of Directors Election. The seats of BBGHAD Board Members Karno, Kuba, and Marine will be up for reelection in November 2023. Project Counsel will brief the BBGHAD Board on the process for the planned election. In addition, the Board will be asked to provide direction to the BBGHAD's Election Official to complete the required measures to conduct the election, including the initial notification of Los Angeles County (Project Counsel).
