- b. <u>BBGHAD CPI Assessment Increase</u>. As the yearly August deadline approaches for the BBGHAD to submit its assessment roll to LA County, the Board will consider adjusting the levy on the current BBGHAD assessment. The Board will consider adoption of Resolution No. 2022/03, which would add the 2021-22 CPI adjustment of 7.9% to the current assessment.

Staff Recommendation: Adopt Resolution No. 2022/03, which will add the current CPI to the BBGHAD assessment.

c. <u>Proposal to Share Beach Monitoring Data with Los Angeles County</u>. In recent months, Westward Beach, east of Zuma, has incurred significant erosion and constructed an emergency shoreline protective device. Through County consultant Russ Boudreau of Coastal Frontiers, County is requested that the BBGHAD share its beach monitoring data (generated since 2009) with County. Board to discuss sharing beach monitoring data with County. (Project Counsel & Russ Boudreau).
