Best rating: A (excellent), is sole carrier that offered coverage after extensive search by broker. Premium would increase from approximately \$13,800 to \$17,300.

Staff Recommendation: Ratify staff's actions to date to bind coverage, approve Kinsale proposal for 2022-23 liability and umbrella insurance, and direct Staff to take actions necessary to renew the existing insurance.
