NOVEL CORONAVIRUS & COVID-19 EMERGENCY ADVISORY NOTICE

Election Official Donesia Gause to administer oaths. (Election Official).

a. <u>BBGHAD Assessment Levy Adjustment.</u> As the yearly August deadline approaches for the BBGHAD to submit its assessment roll to LA County, the Board will consider adjusting the levy on the current BBGHAD assessment. The Board will consider adoption of Resolution No. 2020/03, which would add the 2019-20 CPI adjustment of 0.1% to the current assessment.

<u>Staff Recommendation</u>: Adopt Resolution No. 2020/03, which will add the CPI adjustment for current fiscal year to the current assessment.
